


Figure 1 shows the use of satellite imagery for aquaculture site selection.




Figure 2: Satellite Imagery for Aquaculture Site Selection. (A map showing a coastal area with different colors representing water quality parameters derived from satellite data. Satellite imagery such as this can be used to identify suitable locations for fish farms that will thrive in Nigeria's coastal regions).
