In Nigeria, for example, the informal sectors contribute a immensely to the growth of the nation's economy and accounts for a significant portion of national Gross Domestic Product (GDP). Examples of economic activities in the informal sector include such occupations as barbing salon, welding, art studios such as graphics and painting, auto electricians, road side mechanics, vulcanizing, street vendors, carpentry, hair dressing salon, car wash, photographic studios, and those that render catering services. Others are those providing services for which they are paid in cash on daily basis. Although the informal sector makes up a considerable segment of the economies in developing nations, it provides profitable opportunities for the poor and has been increasing speedily since the 1960s.

According to the International Monetary Fund, (2021), the unregistered domestic enterprises consist of a significant portion of Nigeria's economy, accounting for as high as 65 percent of GDP. The informal sectors

create more than half of the country's overall economic output and accounts for threeof the entire employment. quarters International Monetary Fund stated further that in Sub-Sahara African, up to 90 percent of jobs outside agriculture are in the informal sector, including household enterprises that are not formally registered, like the domestic workers, the taxi drivers and street vendors. The International Labour Organisation, (2020) is of the opinion that informal economy workers often work in the most risky jobs situation across the entire economic sectors. The informal sector engaged predominantly non-waged workers in unstable work process. Newman, et al (2009) opined that only a small portion of Africa's labour force-mainly males has formal wage-paying jobs in the cities. Most of the labour force is employed in subsistence production in rural areas or in the informal sector of the urban economy. They stated further that the latter often involves women and children, and they include petty trade and other urban services such as cleaning, repairs, manual labour and handicrafts while the lowest earnings come from the rural subsistence occupations which generally require basic traditional skills.

Challenges of the Informal Sector

The informal sector creates a possibility for a vast percentage of the nation's population to break out from extreme poverty and receive earnings that is reasonable for survival. Despite the overall contributions of the sector to the growth of the nation's economy, a larger percentage of the poor are in the informal sector and this poses a threat to the sustainability of the nation's economy. A shortcoming of the informal businesses is that they lack the technical know-how for growth and survival of the business. Another identified problem is that informal sector has the ability of retaining her workforce in unskilled occupation for an indefinite period. Furthermore, the work-related hazard are compounded by such factors as lack of pension and health insurance scheme, low coverage of social safety measures, unusual working hours. living poor wage, inconsistent earnings, high exposure to danger, and not protected by labour laws, Others include, poor quality living, summarily dismissal of employees, and the ability to make any savings is grossly impossible due to poor remuneration.
