## **ARTIFICIAL INTELLIGENCE FOR ENHANCING QUALITY VOCATIONAL EDUCATION AND SUSTAINABLE DEVELOPMENT AMID UNCERTAINTY IN NIGERIA**

### **Abstract**

*This paper examines artificial intelligence as a strategic tool for enhancing the quality of vocational education to promote sustainable development amid prevailing uncertainties in Nigeria. Key concepts such as artificial intelligence, vocational education, and sustainable development are critically explored. The paper also highlights the current uncertainties facing Nigeria and identifies the essential components of quality vocational education. Furthermore, it discusses the benefits of quality vocational education as well as the challenges confronting vocational education in the Nigerian context. In addition, the paper analyzes the applications of artificial intelligence in vocational education, including its potential advantages and associated challenges. The study recommends, among other measures, that the Federal Government of Nigeria, in collaboration with the private sector, should make substantial investments in AI technologies and training programs to support vocational institutions. Adequate funding is considered crucial for upgrading infrastructure, modernizing curricula, and building instructors' capacity in order to achieve national educational goals. It also recommends continuous professional development for vocational educators to strengthen their AI-related competencies and keep pace with emerging technological innovations. Furthermore, policymakers are urged to ensure equitable access to AI technologies across regions and population groups and to develop policies that prioritize sustained investment in artificial intelligence for education.*

### **Introduction**

Nigeria, since attaining independence, has continued to grapple with persistent uncertainties that have given rise to numerous challenges, including widespread poverty, unemployment, and insecurity. With an estimated population of about 200 million people, Nigeria is the most populous country in Africa and ranks as the sixth most populous globally (United Nations Department of Economic and Social Affairs [UNDESA], 2018). According to the Central Intelligence Agency World Factbook (2021), nearly 60% of the population is below the age of 24, resulting in a predominantly youthful population and a high dependency ratio. Projections indicate that Nigeria's population will double within the next three decades, positioning the country as the world's third most populous nation, driven by an annual growth rate of approximately 2.5 percent (UNDESA, 2019). In addition, Nigeria faces significant economic challenges, particularly the increasing incidence of extreme poverty. Despite having a population far smaller than India's, Nigeria overtook India in 2018 as the country with the largest number of people living in extreme poverty (Quartz Africa, 2018). The World Bank (2021) reports that nearly 40% of Nigerians survive on less than one US dollar per day. This situation is further compounded by high levels

of unemployment and underemployment, especially among young people. Moreover, ongoing conflicts in the northern regions and climate change–induced extreme weather conditions have intensified food insecurity across the country. These uncertainties have a significant impact on national development and the overall well-being of citizens. Nevertheless, the challenges confronting Nigeria are not insurmountable, as issues such as unemployment can be mitigated through the effective implementation of quality vocational education across all levels of the educational system. This suggests that when adequately prioritized and supported through the integration of artificial intelligence, quality vocational education can play a vital role in fostering Nigeria’s sustainable development. Artificial Intelligence (AI) refers to machine-based systems capable of generating decisions, recommendations, or predictions in pursuit of human-defined objectives (Organisation for Economic Co-operation and Development [OECD], 2019). The concept has attracted considerable attention from scholars and researchers worldwide and has been a major focus of academic discourse at numerous conferences. As a rapidly evolving and influential technology, AI is transforming virtually every sector, with notable applications in education, healthcare, agriculture, and other fields. The advancement of AI technologies has been described as a key driver of the Fourth Industrial Revolution, creating new opportunities particularly for developing economies (Schwab, 2016). According to the European Commission (2018), AI systems demonstrate intelligent behavior by analyzing their surroundings and acting with varying degrees of autonomy to achieve defined objectives. Similarly, Russell and Norvig (2020) describe AI as the study of agents that perceive their environment and take actions accordingly. Artificial intelligence spans multiple sectors, demonstrating its versatility and effectiveness across a wide range of applications. Through AI, computer systems assume roles traditionally performed by humans, enabling them to address complex and significant problems. The International Finance Corporation (2020) identifies AI as a critical component in efforts to reduce poverty and promote shared prosperity, as it lowers the cost and barriers associated with private-sector solutions, extends reach beyond conventional approaches, and stimulates investment opportunities in emerging markets. Furthermore, AI holds considerable promise in advancing the Sustainable Development Goals (SDGs) by providing AI-as-a-service solutions and generating micro-level data through mobile technologies and other digital devices (Schwab, 2016). Sustainable development is commonly understood as development that satisfies present needs without undermining the capacity of future generations to meet their own needs (World Commission on Environment and Development, as cited in Olojuolawe, 2024). It involves promoting economic growth while ensuring the sustainable management of natural resources and the equitable distribution of benefits across generations (OECD, 2023). The United Nations Environment Programme (UNEP) (2022) further describes sustainable development as development that aligns economic and social advancement with environmental protection. Similarly, Raworth (2017) conceptualizes sustainable development as maintaining a balance between meeting human needs and respecting planetary ecological limits, thereby creating a safe and just space for humanity. The United Nations (2015) frames sustainable development as the pursuit of peace and prosperity for both people and the planet, now and in the future, through the 17 Sustainable Development Goals, which emphasize economic, social, and environmental integration. According to the International Institute for Sustainable

Development (IISD) (2022), sustainable development entails the integration of environmental sustainability, economic vitality, and social equity to secure a high-quality future for all, with education serving as a key enabling factor. Education is a process of social and cultural development through which individuals are nurtured to realize their potentials, talents, and skills, contributing both to personal growth and societal advancement. It serves as a key indicator of knowledge and skill acquisition, enabling individuals to develop cognitive and innovative abilities that allow them to participate meaningfully in societal development. Vocational education, a component of Technical and Vocational Education and Training (TVET), plays a vital role in equipping individuals with the skills and knowledge required for employment and self-reliance. It involves structured programs designed to impart practical skills and technical knowledge that prepare learners for recognized trades and professions. In Nigeria, vocational education is regarded as an essential strategy for combating youth unemployment, reducing poverty, and promoting economic development. Often used interchangeably with TVET, vocational education in Nigeria includes programs aimed at developing practical competencies for both employment and entrepreneurship (Okoye & Arimonu, 2016). Despite Nigeria's abundant human and material resources, the country faces challenges such as high unemployment and underemployment, a mismatch between educational outcomes and labor market needs, and a heavy youth reliance on government employment. Vocational education is therefore crucial, offering individuals pathways to economic independence and self-reliance while supporting national goals of economic diversification and sustainable development. According to the Federal Republic of Nigeria (FRN, 2013), vocational education encompasses not only general education but also the study of technologies and related sciences, along with the acquisition of practical skills, knowledge, attitudes, and understanding relevant to occupations across various economic and social sectors. It equips individuals with the technical capabilities necessary to drive industrialization and economic growth. Abanyam et al., cited in Okorieocha et al. (2024), assert that many countries recognize vocational education as essential for empowering youth with practical skills for productive livelihoods. Programs under vocational education, as noted by Ibe (2016), include Industrial Technology Education, Agricultural Science Education, Home Economics Education, Computer Education, and Business Education. Ultimately, vocational education is an integral part of inclusive education, fostering active citizenship and enabling individuals to contribute positively to both their personal wellbeing and the broader economic development of society (Okorieocha et al., 2024). The United Nations (2015) established the 17 Sustainable Development Goals (SDGs) under the 2030 Agenda for Sustainable Development, which explicitly incorporates vocational education. Within Goal 4, "ensuring inclusive and quality education for all and promoting lifelong learning," a specific target emphasizes vocational education: to significantly increase the number of youths and adults with relevant skills for employment, decent jobs, and entrepreneurship by 2030. Vocational education provides a structured pathway that equips individuals with practical skills and knowledge for specific trades, crafts, and careers across secondary, post-secondary, and adult education levels. Unlike traditional academic education, vocational education prioritizes hands-on experience and specialized expertise in fields such as plumbing, electrical work, welding, and information technology (Kis & Weko, 2020).

In Nigeria, the government has introduced various initiatives to strengthen vocational education, including the National Vocational Qualification Framework (NVQF), which standardizes assessment and certification of vocational skills; the Industrial Training Fund (ITF), which supports internships and practical training programs; and the National Directorate of Employment (NDE), which provides skill acquisition and entrepreneurship programs for unemployed youth. The private sector and non-governmental organizations have also contributed significantly. For instance, companies like the Dangote Group and NGOs such as the Skills Development Initiative Nigeria offer training programs and collaborate with vocational institutions to improve the quality of education. Despite these efforts, vocational education in Nigeria has shown limited impact on reducing unemployment, poverty, and insecurity, highlighting the urgent need for quality vocational education enhanced by modern technologies such as artificial intelligence (AI). Quality, defined as superiority in kind (Merriam-Webster Dictionary, 2024), in this context refers to well-structured and organized vocational programs that employ relevant teaching methods and modern facilities to impart practical skills and technical knowledge aligned with labor market demands. According to UNESCO (2020), quality vocational education integrates technical knowledge, practical skills, and core competencies such as problem-solving, communication, and adaptability, while remaining responsive to economic trends, technological advancements, and local labor market needs. In Nigeria, vocational education is enshrined in the National Policy on Education (Federal Republic of Nigeria, 2013), emphasizing hands-on training alongside theoretical knowledge to ensure graduates meet industry standards and contribute effectively to national economic development.

### **Key Components of Quality Vocational Education**

1. **Dynamic Curriculum:** A hallmark of quality vocational education is a curriculum that is responsive to industry demands. Continuous curriculum review and collaboration with stakeholders, including employers, trade unions, and policymakers, help ensure relevance and alignment with emerging technological trends (OECD, 2019). Courses in areas such as automation, artificial intelligence, and renewable energy have become increasingly vital due to their growing significance in the global economy, highlighting the need for a comprehensive and up-to-date curriculum to foster quality vocational training.
2. **Qualified Educators:** Competent instructors with both technical expertise and pedagogical skills are essential for delivering high-quality vocational education. Teacher training programs should focus on enhancing educators' proficiency in modern instructional strategies and technological tools to optimize the teaching and learning process (Okebukola, 2022).
3. **Modern Practical Training Facilities:** Quality vocational education requires access to advanced practical training facilities. State-of-the-art equipment and laboratories are critical for hands-on learning, allowing students to apply theoretical knowledge in simulated real-world environments. Examples include automotive workshops, digital fabrication labs, and agricultural training centers, which provide learners with the opportunity to develop and refine practical skills (UNESCO-UNEVOC, 2021).



4. **Accreditation and Standardization:** Accreditation and standardization are vital to maintaining the quality of vocational education. Adhering to national and international regulatory frameworks ensures that institutions meet established benchmarks and maintain consistency in training programs (International Labour Organization, 2019). Standardized assessments and accreditation processes are key mechanisms for ensuring program credibility and quality.
5. **Soft Skills Development:** In addition to technical expertise, quality vocational education emphasizes the cultivation of soft employability skills, such as communication, teamwork, and leadership. These competencies enhance graduates' adaptability and employability, enabling them to succeed in diverse professional settings (World Bank, 2020).

### **Benefits of Quality Vocational Education**

Quality vocational education plays a crucial role in driving economic growth by addressing skill shortages in key sectors. In Nigeria, industries such as agriculture, construction, and information technology require a consistent supply of skilled workers to enhance productivity and innovation (Adeyemi & Oluwole, 2021). By equipping individuals with relevant competencies, vocational education improves labor market efficiency and helps reduce unemployment.

1. **Self-Reliance and Empowerment:** Vocational education empowers individuals to secure employment or establish businesses, improving their economic standing. The International Labour Organization (2019) highlights its potential to break the cycle of poverty, particularly in developing countries like Nigeria.
2. **Social Inclusion:** Vocational programs foster social inclusion by providing marginalized groups—such as women, persons with disabilities, and out-of-school youth—with access to skills training. This enables participants to contribute meaningfully to society and enhance their quality of life (UNESCO, 2020).
3. **Technological Innovation and Advancement:** By integrating emerging technologies, including artificial intelligence (AI) and automation, vocational education promotes technological innovation. Graduates trained in these areas are better prepared to meet the demands of Industry 4.0 (Nguyen et al., 2020).

### **Challenges to Quality Vocational Education in Nigeria**

1. **Insufficient Funding and Limited Government Support:** A major barrier is inadequate funding, which leaves many vocational institutions with outdated facilities and equipment (Okebukola, 2022). Limited governmental attention constrains the development of practical, technology-driven learning environments.
2. **Skills Mismatch:** Many graduates lack the competencies required by industries, due to outdated curricula, minimal industry participation in program design, and weak collaboration between institutions and employers. This gap limits the relevance of vocational education to the labor market (Adeyemi & Oluwole, 2021).



3. **Negative Public Perception:** Vocational education is often undervalued compared to academic education, discouraging enrollment and reducing its impact on workforce development (UNESCO-UNEVOC, 2021).
4. **Shortage of Qualified Educators:** A lack of skilled vocational instructors and insufficient professional development opportunities undermine the quality of training. Many educators lack both technical and pedagogical expertise (World Bank, 2020).
5. **Limited Technology Integration:** Inadequate digital infrastructure and minimal use of modern technologies, such as AI, hinder experiential learning and the acquisition of digital skills essential for today's workforce (Nguyen et al., 2020).

### **Artificial Intelligence as a Catalyst for Enhancing Quality Vocational Education in Nigeria**

Vocational education is vital for addressing unemployment and promoting economic growth. In Nigeria, however, its effectiveness is constrained by challenges such as inadequate infrastructure, limited access to high-quality training, and a volatile socio-economic environment. The emergence of Artificial Intelligence (AI) offers transformative opportunities to overcome these limitations and elevate the quality of vocational education. AI can personalize learning experiences, optimize administrative processes, automate routine tasks, and generate data-driven insights to inform decision-making (Luckin et al., 2016). Integrating AI into vocational education also aligns with Sustainable Development Goal 4, which advocates for inclusive and quality education for all. This paper explores the potential of AI as a tool to reform vocational education in Nigeria, enhancing resilience and adaptability amidst prevailing uncertainties. Research indicates that AI applications in education can significantly improve learning outcomes and operational efficiency. AI enables personalized content tailored to learners' unique needs (Holmes et al., 2019). In vocational education, AI-powered simulations and virtual reality (VR) enhance practical skills by providing safe, controlled environments for learners to practice complex tasks. Moreover, AI can support SDG 4 by improving both access to and quality of education. For example, AI-driven analytics can identify skill gaps in the labor market, guiding curriculum development to better align with industry demands (Nguyen et al., 2020).

### **Applications of AI in Vocational Education**

1. **Learner-Centered and Adaptive Platforms:** AI-driven systems personalize learning by adjusting content based on individual learner needs, abilities, and progress. Adaptive platforms can tailor the complexity and pace of courses, such as welding or electrical/electronic training, to optimize skill acquisition (Chen et al., 2021).
2. **Simulated Training and Virtual Reality:** AI integrated with VR provides realistic simulations of work environments, allowing learners to practice tasks safely. Fields such as automotive repair, construction, and healthcare benefit from interactive simulations that replicate real-world scenarios without associated risks (Martínez & Hernández, 2020).
3. **Automated Assessment and Feedback:** AI automates performance evaluation, offering immediate, objective feedback. For instance, technical projects like coding or graphic design can be assessed against predefined criteria, reducing instructors' workload and enhancing learning (García-Peñalvo et al., 2019).

4. **Virtual Tutors and Chatbots:** AI-powered virtual tutors and chatbots offer continuous support, answering questions, explaining concepts, and guiding learners through coursework, particularly for technical challenges outside classroom hours (Zawacki-Richter et al., 2019).
5. **Predictive Analytics for Career Guidance:** AI analyzes labor market trends to help learners select vocational paths aligned with in-demand skills. Machine learning algorithms can predict emerging job roles in sectors like renewable energy, digital manufacturing, and AI itself (Hussin et al., 2021).
6. **AI-Driven Skill Development Tools:** Advanced tools such as 3D printers, CNC machines, and smart diagnostic systems provide real-time feedback and analytics, equipping students with industry-specific competencies in areas like precision engineering and advanced manufacturing (Yu et al., 2020).
7. **Learner Analytics:** AI tracks student progress, identifies at-risk learners, and supports interventions to improve engagement and prevent dropouts, allowing educators to optimize instructional strategies (Siemens et al., 2020).
8. **Hybrid and Remote Learning Solutions:** AI enables virtual labs, real-time collaboration, and remote assessments, facilitating access to high-quality vocational education for learners in rural or underserved areas (Garrison et al., 2021).
9. **Curriculum Design and Content Creation:** AI assists educators in designing relevant, engaging curricula by analyzing industry trends and learner needs. Natural Language Processing (NLP) tools can generate instructional content, quizzes, and tutorials, ensuring alignment with industry standards (Bates et al., 2020).
10. **Promoting Learner Inclusivity:** AI technologies enhance accessibility for learners with disabilities. Speech recognition aids those with hearing impairments, while text-to-speech supports visually impaired learners, promoting equitable access to vocational education (McLaughlin & Knoop, 2020).

### **Challenges of Artificial Intelligence (AI) in Vocational Education**

While integrating Artificial Intelligence (AI) into vocational education has the potential to transform teaching, learning, and skill development in Nigeria, several challenges hinder its effective adoption. Addressing these obstacles requires substantial investment in infrastructure, capacity building, and the development of policies to ensure the ethical and responsible use of AI.

1. **High Implementation and Maintenance Costs:** One major barrier is the high cost associated with acquiring and maintaining AI technologies. Vocational institutions often face budgetary limitations, making it difficult to invest in AI-powered tools, software, and infrastructure. For example, installing adaptive learning platforms or AI-enabled simulators involves significant upfront expenditures, limiting access for underfunded institutions (UNESCO, 2019; Hussin et al., 2021).
2. **Insufficient Infrastructure and Equipment:** Many vocational institutions lack the essential hardware, reliable internet connectivity, and electricity needed to support AI integration. This technological gap restricts the widespread adoption of AI-driven training programs in Nigeria (Siemens et al., 2020).



3. **Shortage of Qualified AI Experts and Trainers:** Effective implementation of AI requires skilled personnel. However, Nigeria faces a scarcity of trained AI experts and vocational educators proficient in AI tools. Limited training programs exacerbate this issue, making it difficult to develop, deploy, and maintain AI-based learning solutions (African Union, 2019; García-Peñalvo et al., 2019).
4. **Ethical and Data Privacy Concerns:** AI systems may perpetuate biases if trained on unrepresentative datasets, potentially creating unequal learning opportunities. Additionally, the collection and storage of student data raise privacy concerns, emphasizing the need for ethical guidelines in AI deployment (Binns et al., 2018; UNESCO, 2019).
5. **Resistance from Educators and Students:** Adoption of AI often faces resistance due to fear of job displacement, skepticism about its effectiveness, or reluctance to change traditional teaching methods. Many vocational curricula are not yet designed for AI integration, necessitating complex curriculum redesigns. Furthermore, unequal access to AI tools can deepen educational inequalities, especially in rural or low-income areas (Zawacki-Richter et al., 2019; Garrison et al., 2021).
6. **Over-Reliance on Technology:** Excessive dependence on AI may reduce interpersonal engagement, mentorship, and development of soft skills such as teamwork, leadership, and communication, which are critical in vocational training (Hussin et al., 2021).
7. **Global Security and Rapid Technological Change:** AI involves processing large amounts of personal and performance data, posing risks of cyberattacks or data breaches. Rapid technological evolution also means that tools quickly become outdated, requiring frequent updates and reinvestment (Chen et al., 2021; Yu et al., 2020).

## **Conclusion**

Vocational education is a cornerstone of Nigeria's education system, providing pathways to employment, entrepreneurship, and economic development. AI offers transformative opportunities to enhance vocational education by enabling personalized learning, improving skill acquisition, and aligning programs with industry demands. However, to fully realize these benefits, Nigeria must address challenges such as infrastructure deficits, capacity gaps, ethical concerns, and social resistance. With strategic investments in infrastructure, equitable access, and skills development, vocational education can harness AI to bridge skill gaps and prepare learners for the future workforce.

## **Recommendations**

1. **Investment in AI Tools and Training:** The Nigerian government and private stakeholders should invest in AI infrastructure, training programs, and curriculum modernization to enable vocational institutions to leverage AI for technological advancement.
2. **Continuous Educator Training:** Vocational instructors should receive ongoing training in AI and emerging technologies to enhance their technical expertise and integrate digital tools into instruction.
3. **Equitable Access and Policy Development:** Policymakers should ensure that AI technologies are accessible across regions and demographics, while enacting policies that prioritize AI investment and regularly review vocational education strategies to align with evolving labor market needs.



4. Ethical Use of AI and Data Management: Institutions should adopt transparent data policies, utilize diverse datasets to reduce bias, and follow guidelines for the ethical use of AI, ensuring respect for human rights and promoting trust in technology.
5. Collaboration with Industry: Vocational institutions should partner with technology companies to develop affordable AI solutions, and strengthen industry linkages to ensure training aligns with labor market demands.
