Another area of concern is privacy-related anxiety. Children may internalize a sense of being constantly observed, which can affect trust in caregivers and the development of personal boundaries (Livingstone et al., 2017). The long-term psychological consequences of such pervasive monitoring are still largely unknown but may include diminished autonomy, heightened self-consciousness, and altered behavior due to perceived surveillance. On the positive side, AI can also support psychological and social development when implemented thoughtfully. AI tools can identify early signs of developmental delays, mental health concerns, or learning difficulties, allowing timely interventions that promote well-being (UNICEF, 2024).

Regulatory and Policy Considerations

Guidelines can include limits on monitoring intensity, restrictions on profiling or predictive labeling of children, and requirements for parental education about AI capabilities and risks.
