## **HARNESSING ARTIFICIAL INTELLIGENCE FOR AGRICULTURAL EXTENSION AND ECONOMIC SUSTAINABILITY IN DELTA STATE, NIGERIA**

### **Abstract**

*This study investigated the potential of Artificial Intelligence (AI) in enhancing agricultural extension services and economic sustainability among farmers in Delta State, Nigeria. Using a cross-sectional survey design, data were collected from 384 farmers across three agricultural zones over a six-month period (March–August 2024). Results revealed that 68.2% of farmers had moderate awareness of AI technologies, while only 23.7% had high awareness levels. The study found significant positive relationships between AI adoption and farm productivity ( $r=0.742$ ,  $p<0.001$ ), with AI-adopting farmers recording 34.6% higher yields compared to non-adopters. Multiple regression analysis showed that education level ( $\beta=0.358$ ,  $p<0.001$ ), access to mobile technology ( $\beta=0.412$ ,  $p<0.001$ ), and extension contact ( $\beta=0.287$ ,  $p<0.01$ ) significantly predicted AI adoption. Economic analysis indicated that farmers utilizing AI-powered advisory services experienced a 28.4% increase in annual income, with return on investment of 2.43:1. However, challenges including poor internet connectivity (81.5%), high smartphone costs (73.8%), and inadequate training (69.3%) were identified as major barriers. The study concludes that while AI presents substantial opportunities for transforming agricultural extension in Delta State, strategic interventions in infrastructure development, capacity building, and policy support are imperative for sustainable adoption.*

### **Introduction**

Agricultural development remains central to Nigeria's economic transformation agenda, with the sector contributing approximately 21.9% to national GDP and employing over 70% of the rural workforce (Olutegbe & Fadairo, 2016; National Bureau of Statistics, 2023). Delta State, located in the Niger Delta region, possesses enormous agricultural potential, characterized by extensive arable land, a favorable tropical climate, and diverse agroecological zones that support the cultivation of cassava, yam, rice, plantain, and oil palm (Azih & Eze, 2023). Despite these advantages, agricultural productivity remains suboptimal, with smallholder farmers facing multifaceted challenges that constrain production optimization and economic sustainability. The agricultural extension system, traditionally serving as the critical link between research institutions and farmers, has been plagued by inadequate funding, insufficient personnel, and ineffective service delivery mechanisms (Chikezie et al., 2022). The farmer-to-extension agent ratio in Nigeria averages 1:5,000 and far exceeds the Food and Agriculture

Organization's recommended ratio of 1:1,000 (Omotayo et al., 2021). This deficit has created significant information gaps, limiting farmers' access to the timely agricultural knowledge necessary for improved farm management. In recent years, Artificial Intelligence (AI) has emerged as a transformative technology with the potential to revolutionize agricultural systems globally (Javaid et al., 2023). AI encompasses machine learning, computer vision, natural language processing, and predictive analytics, offering innovative solutions for precision agriculture, pest management, weather forecasting, and market information systems (Sharma et al., 2022). In developing countries, AI-powered mobile applications have demonstrated significant impact in bridging extension service gaps, providing farmers with personalized advisory services, early warning systems, and market linkages (Bacco et al., 2019). Despite the global momentum toward digital agriculture, empirical evidence on AI adoption and its implications for agricultural extension and economic sustainability in Delta State remains limited. The digital divide, characterized by unequal access to information and communication technologies between urban and rural areas, poses significant challenges to AI adoption in agricultural communities (Aker et al., 2016). Delta State's rural farming communities face infrastructural deficits, including poor internet connectivity, limited electricity supply, and low smartphone penetration, which may constrain deployment of AI-powered agricultural solutions (Okello et al., 2014). This study addresses these gaps by providing empirical evidence on the current state of AI awareness and adoption among farmers in Delta State, examining the relationship between AI utilization and agricultural productivity, and assessing the economic implications of AI-powered extension services. The findings will contribute to the growing body of knowledge on digital agriculture in developing countries and provide actionable insights for policymakers, extension agencies, technology developers, and development partners.

### **Objectives of the Study**

The broad objective is to examine the potential of Artificial Intelligence in enhancing agricultural extension services and promoting economic sustainability among farmers in Delta State, Nigeria. Specific objectives are:

1. To assess farmers' level of awareness and adoption of AI technologies for agricultural purposes in Delta State.
2. To examine the relationship between AI adoption and agricultural productivity among farmers in Delta State.
3. To evaluate the economic impact of AI-powered extension services on farmers' income and economic sustainability in Delta State.

### **Methodology**

#### **Research Design and Study Area**

This study employed a cross-sectional survey research design to collect data from farmers at a single point in time. The study was conducted in Delta State, Nigeria, located in the Niger Delta region between latitudes 5°00' and 6°30' N and longitudes 5°00' and 6°45' E. Delta State covers approximately 17,698 square kilometers with a population of about 5.6 million people (National Population Commission, 2023). The state is characterized by a tropical climate with annual rainfall ranging from 2,500mm to 4,000mm, and diverse agro-ecological zones including freshwater swamp, mangrove swamp, and upland areas (Azih & Eze, 2023).

The state is administratively divided into 25 Local Government Areas (LGAs) organized into three agricultural zones: Delta North, Delta Central, and Delta South. Agriculture is the primary occupation for the majority of the rural population, with major crops including cassava, yam, plantain, maize, rice, vegetables, oil palm, and rubber (Arokoyu et al., 2020).

### Population and Sampling

The target population comprised all registered smallholder farmers in Delta State actively engaged in crop production and affiliated with the Agricultural Development Programme (ADP) and farmers' cooperatives. According to the Delta State ADP (2023), there are approximately 187,450 registered smallholder farmers across the three agricultural zones.

The sample size was determined using Yamane's (1967) formula:

$$n = N / [1 + N(e)^2]$$

Where  $n$  = sample size,  $N$  = population size (187,450),  $e$  = margin of error (0.05)

$$n = 187,450 / [1 + 187,450(0.0025)] = 399.2 \approx 400$$

The sample was adjusted to 420 farmers to account for potential non-response. After data cleaning, 384 questionnaires were found suitable for analysis, representing a response rate of 91.4%.

A multi-stage sampling technique was employed:

- Stage 1: Proportionate sampling selected farmers from each agricultural zone: Delta North (140 farmers, 36.5%), Delta Central (146 farmers, 38.0%), and Delta South (98 farmers, 25.5%).
- Stage 2: Simple random sampling selected two LGAs from each zone (six LGAs total).
- Stage 3: Random sampling selected farm communities from each LGA.
- Stage 4: Systematic random sampling selected individual farmers from ADP and cooperative society lists.

### Research Instrument and Data Collection

A structured questionnaire served as the primary research instrument, comprising five sections:

- Section A: Awareness and knowledge of AI technologies (4-point Likert scale: Very Aware=4, Aware=3, Slightly Aware=2, Not Aware=1)
- Section B: Adoption of AI technologies (types of tools used, frequency, duration, perceived usefulness)
- Section C: Agricultural productivity indicators (crop yield, input efficiency, pest/disease management, production costs)
- Section D: Economic sustainability measures (annual income, profit margins, ROI, market access, price realization)

The questionnaire was validated by three experts in agricultural extension and rural sociology. A pilot study with 30 farmers tested reliability, with Cronbach's alpha coefficients of 0.84 (awareness scale), 0.79 (adoption scale), and 0.82 (economic sustainability scale), indicating satisfactory internal consistency. Data were collected through face-to-face interviews by six trained research assistants fluent in local languages (Urhobo, Isoko, Itsekiri, and Ijaw). Interviews lasted approximately 45-60 minutes. Secondary data were obtained from farmers' records, ADP databases, and cooperative society documentation.

### Data Analysis

Data were analyzed using SPSS version 26.0. Descriptive statistics (frequencies, percentages, means, and standard deviation) summarized awareness levels and adoption patterns. Inferential statistics included:

- Pearson Product-Moment Correlation for relationships between continuous variables
- Independent Samples t-test for comparing economic indicators between AI adopters and non-adopters
- Chi-square test for associations between categorical variables

Awareness level was categorized as: Low awareness (Mean < 2.0), Moderate awareness (Mean = 2.0-3.0), High awareness (Mean > 3.0). Adoption level was classified as: Non-adopters (no AI tools), Low adopters (1 AI tool), Moderate adopters (2-3 AI tools), High adopters (4+ AI tools).

## Results

Table 1 indicates that farmers had the highest awareness of mobile weather forecasting apps (Mean=2.83), followed by AI-powered pest/disease identification apps (Mean=2.45) and digital market information platforms (Mean=2.32). Conversely, machine learning yield prediction tools (Mean=1.59), precision irrigation systems (Mean=1.68), and AI-based soil analysis apps (Mean=1.79) recorded the lowest awareness levels. The grand mean awareness score of 2.10 indicates moderate overall awareness of AI technologies among farmers in Delta State.

Table 2 reveals that 50.3% of farmers were non-adopters of AI technologies. Among adopters (49.7%), low adopters constituted 26.0%, moderate adopters 18.5%, and high adopters only 5.2%. The most widely adopted AI tool was mobile weather forecasting apps (81.7% of adopters), followed by digital market information platforms (45.5%) and AI-powered pest/disease identification apps (33.5%).

### Relationship between AI Adoption and Agricultural Productivity

Table 4 demonstrates significant differences in productivity indicators between AI adopters and non-adopters. AI adopters recorded a mean crop yield of 3.87 tons/ha compared to 2.87 tons/ha for non-adopters, representing a 34.6% increase in productivity ( $t=11.23$ ,  $p < 0.001$ ). Adopters demonstrated superior input use efficiency, utilizing 23.1% less fertilizer and requiring 40.7% fewer pesticide applications. Pest and disease severity was significantly lower among adopters (Mean=2.1 vs. 3.6;  $t=-14.68$ ,  $p < 0.001$ ). Water use efficiency showed marked improvement among AI adopters, who used 37.0% less water per kilogram of produce. Production costs per hectare were significantly lower for adopters (₦163,450 vs. ₦198,340), representing a 17.6% cost reduction. Post-harvest losses were dramatically reduced among AI adopters (12.4% vs. 23.7%), nearly halving losses compared to non-adopters. All differences were statistically significant at  $p < 0.001$ .

The correlation analysis revealed strong positive relationships between AI adoption scores and various productivity measures. The relationship between AI adoption and crop yield was particularly strong ( $r=0.742$ ,  $p < 0.001$ ), indicating that increased utilization of AI technologies was associated with substantial productivity gains.

Table 5 presents a comprehensive economic impact assessment, revealing substantial economic benefits for AI adopters. Annual farm income for AI adopters averaged ₦625,780 compared to ₦487,300 for non-adopters, representing a 28.4% increase ( $t=7.23$ ,  $p < 0.001$ ). Gross profit margin increased from 31.2% to 43.7%, representing a 40.1% improvement, while net profit margin rose from 18.7% to 28.4%, a 51.9% enhancement. The Return on Investment ratio was substantially higher for adopters (2.43:1 vs. 1.52:1), indicating that for every Naira invested, AI adopters realized ₦2.43 in returns compared to ₦1.52 for non-adopters—a 59.9% improvement. The savings rate among AI adopters was 18.6% compared to 11.4% for non-adopters. Access to credit was significantly higher among adopters (67.5%) compared to non-adopters (43.0%). Market-related economic indicators revealed that AI adopters achieved 87.3% of the prevailing market price compared to only 68.7% for non-adopters, representing a 27.1% improvement in price realization. This was facilitated by reduced time to market (2.8 vs. 5.6 days) and lower marketing costs (8.3% vs. 15.7% of revenue).

The cost-benefit analysis demonstrates the strong economic viability of AI adoption. The total annual cost averaged ₦66,600 per farmer, with internet/data subscription (36.0%) and smartphone device cost (23.4%) constituting the largest components. Against these costs, farmers realized total annual benefits of ₦242,840, yielding a net benefit of ₦176,240 and an impressive benefit-cost ratio of 3.65:1. The payback period of 3.3 months indicates rapid return on investment.

### Discussion

The findings provide comprehensive insights into AI's role in transforming agricultural extension services and enhancing economic sustainability among farmers in Delta State, Nigeria.

### Farmers' Awareness and Adoption of AI Technologies

The study revealed moderate awareness levels (grand mean=2.10) of AI technologies, with mobile weather forecasting apps, pest/disease identification apps, and digital market platforms being the most recognized tools. This corroborates Javaid et al. (2023), who noted that basic AI applications with immediate practical utility tend to have higher awareness among smallholder farmers. However, the adoption rate of 49.7%, with only 5.2% being high adopters, suggests a significant awareness-adoption gap, consistent with observations by Sharma et al. (2022) that knowledge alone is insufficient for technology uptake without addressing infrastructural and capacity barriers. The predominance of mobile weather forecasting apps (81.7% among adopters) reflects farmers' immediate need for climate information, supporting findings by Aker et al. (2016) that weather-related services often serve as entry points for digital agriculture adoption. The minimal adoption of advanced technologies such as precision irrigation systems (4.2%) and machine learning yield prediction tools (3.1%) indicates that cost, complexity, and perceived relevance significantly influence adoption decisions. The 50.3% non-adoption rate highlights persistent challenges in agricultural technology dissemination. The finding that only 37.2% of farmers had internet access underscores the digital divide that constrains AI adoption in rural Delta State, echoing concerns raised by Chikezie et al. (2022) about infrastructure deficits in Nigerian agricultural communities.

### AI Adoption and Agricultural Productivity

The study demonstrated a strong positive relationship between AI adoption and agricultural productivity, with adopters achieving 34.6% higher yields than non-adopters. This finding aligns with Bacco et al. (2019), who reported 20-40% yield improvements associated with precision agriculture technologies in developing countries. The correlation coefficient of 0.742 between AI adoption scores

and crop yield provides robust evidence of AI's productivity-enhancing effects. The superior input use efficiency observed among AI adopters—23.1% less fertilizer use and 40.7% fewer pesticide applications—demonstrates AI's potential for sustainable intensification. These findings resonate with Sharma et al. (2022), who documented significant input optimization through AI-powered precision agriculture systems. The 37.0% improvement in water use efficiency among adopters is particularly relevant for Delta State, where climate variability increasingly threatens agricultural productivity. The dramatic reduction in post-harvest losses from 23.7% to 12.4% among AI adopters represents substantial economic value creation. AI-enabled market information systems that facilitate rapid market access and optimal harvest timing appear to address this challenge effectively, as suggested by the reduced days to market (2.8 vs. 5.6 days) observed among adopters.

### **Economic Impact and Sustainability**

The 28.4% increase in annual income among AI adopters (₦625,780 vs. ₦487,300) provides compelling evidence of AI's economic impact. The improved net profit margin of 28.4% compared to 18.7% for non-adopters, alongside the favorable ROI ratio of 2.43:1, demonstrates the strong economic viability of AI adoption despite initial investment costs. The 27.1% improvement in market price realization among AI adopters (87.3% vs. 68.7% of market price) addresses a long-standing challenge identified by Olutegebe and Fadaïro (2016): exploitation of farmers by middlemen due to information asymmetry. Digital market platforms appear to empower farmers with price transparency and direct market access, reducing intermediary margins and enhancing farm gate prices. The finding that AI adopters had significantly higher access to credit (67.5% vs. 43.0%) is particularly important for economic sustainability. This aligns with observations by Javaid et al. (2023) that digital records and enhanced productivity enabled by AI create creditworthiness signals that financial institutions recognize, thereby improving farmer access to capital.

### **Conclusion**

Artificial Intelligence represents neither a panacea for all agricultural challenges nor an impossible dream for Delta State farmers. Rather, it constitutes a powerful set of tools that, when deployed thoughtfully with attention to infrastructure, capacity, equity, and sustainability considerations, can significantly enhance agricultural extension effectiveness and farmer economic wellbeing. The pathway forward requires coordinated action from government, private sector, civil society, and farmers themselves, guided by evidence and committed to inclusive development. The favorable benefit-cost ratios and demonstrated impacts documented in this study justify optimism and investment, while the identified barriers demand urgent attention to ensure AI's transformative potential benefits all farmers, not just the privileged few.

### **Recommendations**

Based on the findings, the following recommendations are proposed:

1. Government and Policymakers should prioritize rural broadband expansion and electricity provision as foundational investments for digital agriculture. Public-private partnerships should be leveraged to accelerate rural connectivity, with specific targets for agricultural communities.
2. Government and Policymakers should redesign extension services to integrate AI tools training extension agents as digital facilitators. Increase extension agent recruitment and equip them with devices and training to support farmer AI adoption.

3. Agricultural Extension Services and Development Organizations should establish digital agriculture demonstration sites in each agricultural zone where farmers can observe AI applications, receive hands-on training, and access devices for experimentation.
4. Farmers and Farmer Organizations should organize into digital agriculture cooperatives for collective bargaining on service costs, shared infrastructure investment, and peer learning support.
